SDP RENEWAL AUDIT REPORT

The renewal audit report from the School District of Philadelphia arrived after the last Board meeting. The report is included in the packet. No findings.

Perhaps the changing of some Board members delayed this process.

THE BUREAU OF SPECIAL EDUCATION CYCLICAL MONITORING (BSE)

The results of the BSE monitoring came in. Lab Charter had an overall 99.98% compliance rate. There are minor corrections to be made and a meeting will be scheduled with the BSE Monitors to review the corrections and the timeline.

INDEPENDENT AUDITOR

The resolution for Milligan and Associates to engage in the independent audit this year is included with the packet. I have asked that the auditors present at the August 2024 meeting to provide a scope of work.

ESSR and ARP/ESSR

The ESSR and ARP/ESSR monitoring were held in May 2024. The monitoring lasted two weeks and reviewed all COVID-19 funds spent to the penny. Serial numbers and inventories were provided, policies were provided, and the CEO was interviewed with pages of single-spaced questions. There is one final questionnaire and a report will be released.

LAB CHARTER WEBSITE

The Lab Charter website was hacked and spammed with porn. It has been an incredible task to clean the site and track where the hack is coming from. Mr. Boyles, Technology Director is working with the host company to clean the site and identify the parties responsible.
